## FROM THE PRESIDENT

2022 was a year of "Creative Genius" and "Annus Horribilis" all rolled into one for the Arcadians Theatre Group. Now that I have your attention, let's delve into what has made it so!

We are so fortunate to have capable, experienced production teams to bring only the best live performances to our audiences. At the time of last year's AGM, *When the Rain Stops Falling* was on stage. Ably Directed by Peter Scrine and set designed by David Thomas, the production team and cast excelled in this masterpiece of theatre.

Arcadians Children's Theatre presented *Xanadu Jr* in April/May again to sell out audiences. The team of Janne-Maree McNeice, Tina Wallace, Valerie Joy Hull and Pauline Young again produced outstanding efforts from our kids. The quality of every production just keeps on getting better!

June 2022 saw *Be More Chill* hitting the stage under the Direction of John Reynolds and Producer Jason Ayers. Musical Director Adele Masters and Choreographer Troy Lester-Reynolds. This fast moving, exciting production saw audiences flocking back to the Miners Lamp.

2022 was our 25<sup>th</sup> Anniversary of owning the Miners Lamp Theatre and we had to celebrate. Director Kerrie Hartin along with Valerie Joy Hull and Pauline Young put together a stella team and cast to help the celebrations along. *Salute to 25 Years at the Miner's Lamp Theatre* showcased our talented performers and our history at the theatre. This was also the first time we partnered with Jaffa at the Corrimal RSL to offer patrons a dinner-show package that was enthusiastically received. We also had the pleasure of inviting Di Richards (Di Dun) to be our special quest performer allowing past members the opportunity of catching up with Di.

ACT returned in September with *Legally Blonde the Musical Jr.* which the cast thoroughly enjoyed presenting to full houses. Patrons and performers had to contend with the World Cycling Championships that were held in Wollongong to world focus with blocked road access and crowds. Thankfully, it all worked smoothly.

Our final production for the year was the mammoth production of *Les Misérables* at the Miner's Lamp. Many said it could not be done but were they wrong. Production team led by Malcolm White, Angela Quinn, Rowan Keyes, Natalie Bazun-Coates and David Greer pulled off the spectacular sold out production. A masterpiece of theatre took place on our stage for which we all should be very proud.

On a sadder note, we celebrated the life of Life Member Diana Brown in October with a service at the Miner's Lamp. Diana passed away in October. Her service to Arcadians over many years was exemplary and she has left a lasting impression on all those that knew her.

In July 2022, we were approached by Wollongong City Council (WCC) after a complaint from neighbours to advise us that "At the time of the DA approval on 5 May 2005 Council had no approval in place for the venue to be used as a "place of entertainment". It went on to say "From a legal point of view, Arcadians should not be using these facilities as no occupation certificate has been issued". Their advice was to seek our own legal advice.

Our honorary Solicitor recommended a specialist solicitor in property law, Foundation Law, and we engaged them same day. They then approached WCC to get assurances that they would not close

the theatre which Council agreed to. Our "Salute to 25 years at the Miners Lamp" concert was in jeopardy of being cancelled.

Since then, Foundation Law have researched all our paperwork and the legal aspects since 2005 to prepare a draft submission to WCC.

In the interim, we had submitted a DA application to build a foyer extension and access ramp at the eastern boundary facing Princes Highway. That was approved towards the end of 2022 with the condition that the LED sign on the front awning be removed. Our solicitor is now drafting a precedent statement to be put into the draft seeking to reverse the LED removal condition.

In addition, we are required to submit a Building Certifiers report based on the National Construction Code when the DA application is to be submitted to WCC. After a couple of site inspections by the Building Certifier, his report arrived Christmas Eve. The report highlights the areas of the National Construction Code that we currently do not meet. Our team of David Greer, Phil McNeice and I have become very familiar with Clause H.101 of the Building Code that applies to places of public entertainment; highlighting a number of Fire safety issued that will need to be addressed prior to the report being submitted with the DA.

The Building Certifier's report highlights a significant number of fire protection issues that will need to be addressed in coming months including installation of 8 fire doors, a smoke extraction system on stage, walls to be fire proofed, installation of a fire panel to control all the fire protection measures, and possible replacement of the stage with appropriately rated load capability among other issues. These are being costed and information gathering progressively giving us a better picture what this will mean for the Group. We will keep you informed as developments occur but suffice to say we still have a long way to go before we can feel secure in continuing to operate out of the Miner's Lamp Theatre. And there will be considerable expense and likely fund raising involved in rectifying the facility. As a result of noise complaints from our neighbours, we also replaced the exit door on the southern side of the building with a soundproof door and added noise reduction components to the air conditioning units which improved performance as well.

I would like to thank the various groups that have made Arcadians what it is. Their reports appear below and they explain what great contributions all our volunteers make. Every member adds value to what we can achieve as a theatre company.

I would like to thank the hard working Board of Director's for their support over the past twelve months. Every person has taken on the responsibility of being a Company Director in the true spirit of their legal obligations. I thank Jason Ayers for his contribution before he retired as Marketing Manager due to personal reasons. His position was then taken up by Isabella Cuff with a steep learning curve required over a short period of time. To Kerrie Hartin whose time and effort required for the Secretary's job is invaluable. Thank you to our Treasurer Lauren Eade who has decided to retire from the Board at this AGM. Lauren has managed to bring our accounting systems up to date and will be handing over to the new Treasurer, a vastly improved package to manage. Unfortunately, Natalie Bazun-Coates has also decided not to stand this year. Her contribution to revamping the Refreshment Bar and introducing new members to the Group has resulted in an amazing transformation of the service. To other Board members, I thank you for your continued support and hard work. To Stephen Barnes who assisted Lauren with her duties on top of his own responsibilities deserves mention.

There is a Constitutional change that we present to members for your consideration. Your Board strongly encourages you to agree with the changes. They are aimed at more clearly defining our status as a Deductible Gift Recipient (DGR) and continuance of our Register of Cultural Organisations (ROCO) status.

In spite of all the challenges raised above, we have been able to make a considerable profit from our activities over the year whilst spending on up-grading aspects of the theatre and legal fees (\$10,000).

Details of these purchases are in the Technical Managers report. Please refer to the Auditors report for the details on our final annual financial results.



## REFRESHMENT BAR

This past year we have been very busy in the Refreshment Bar with our first full year of shows post Covid lockdowns and have managed to turn over all our stock on a regular basis. It has been a challenge to adequately manage our stock levels for each production due to our fluctuating patron demand but with updated sales records we should be able to improve on this into the future. As I step down from the role of Refreshment Bar manager to spend more time with my family I would like to acknowledge and personally thank my amazing team of volunteers who operate the Refreshment Bar with efficiency and enthusiasm always ensuring our patrons have fast service with smile.

## **GRANTS REPORT**

Bit of a mixed bag for us this year on the grants front. Here are the updates from the past year:

- Completed our reporting requirements for the successful \$10,000 grant in the previous year under the Community Building Partnerships Program. Funds were deposited in March 2022.
- Applied for \$60,000-\$90,000 under the next round of the Community Building Partnerships Program and was unsuccessful.
- Applied for \$20,000 under the BlueScope WIN Community Partners Program, was given a \$2000 donation instead.
- Due to pending DAs we chose not to apply for NSW Infrastructure Grants as we would not meet the eligibility criteria.
- Awaiting an outcome for a \$1400 grant submission for portable costume racks.
- Strengthened relationships with local MPs to help demonstrate funding needs.
- Developed a grants wish list for future submissions.

## MONDAY MORNING MAINTENANCE REPORT

Herewith is the report to the 2023 AGM from the Monday Morning Maintenance Team.

- Fire safety checks have been carried out.
- Each Monday all the garbage bins are attended to and sorted out into garbage, recycling and return and earn. Derek, Christine and Roger then gather the cans and plastic bottles and take them to Vinnies for our refund which has amounted to just over \$250 for 2022/3. We also endeavour to keep the fridges clean and remove old food stuffs etc.
- Ongoing cleaning of the slime from the drains around the main shed has occurred regularly.
   The southern side path is now much easier to look after since the bitumen work was carried out.
- Pest control is still being undertaken.
- Our Welder Extraordinaire, Michael has repaired the broken side gate and it will last us a bit longer.
- Our Mower Man, David Edwards, is doing a great job of keeping the growth at the back of the shed under control and also, along with Derek and his sprayer, the random weeds are being dealt with!
- A new (to us) sink was installed outside the kitchen for paint clean-ups etc.
- New guard rails outside the dressing rooms were installed.
- Bollards were installed on the newly surfaced area in front of the Costume Room.
- A new step outside the container has been installed and the landscaping work on the northern side of the driveway has commenced.
- Frames are/have been made for the show posters as some were damaged.
- There was a huge rejig of the main storage shed with new shelving being installed which has made a big difference. At that time, there was also a big cull of unneeded flats and broken pieces etc which were removed during the year in 3 skips.
- The team was again very happy to contribute to the sets for shows, in particular for Les Mis and for the Salute to 25 Years at the Lamp Concert.
- There is always ongoing maintenance required for the theatre in general, broken curtain tracks, front door issues, fixing taps, broken chairs, props etc. These things are usually dealt with straight away if they are jobs the team can do.
- Refurbishment and painting of the corridor between the stage and dressing rooms was completed.
- The supplies of toilet rolls, hand paper, detergent, paper plates, serviettes is also being maintained by the team.
- The Life Members Board and the ACT and adult show boards are being updated at the time of writing.
- A number of trips to Bunnings have been made for purchases of tools and equipment, timber and supplies for maintenance work and for set pieces for productions.

We all continue to enjoy the camaraderie on a Monday and find it very satisfying to be able to contribute to the group in this way. We enjoy the sweet treats supplied by Christine, Marie and Malcom each Monday and enjoy our lunchtimes together.

## **TECHNICAL CUSTODIAN**

The past twelve months has been another busy year at the Miner's Lamp from a technical perspective. In early 2022 we completed the installation of stage traps and wall boxes that contain power, lighting, data and audio outlets. Power is now available at the front of the stage.

March saw the temporary removal of the stage portal for *When The Rain Stops Falling* and then in November, the stage portal was installed in its forward position for *Les Misérables*.

In July, our retractable seating unit, drapery (curtains, legs, borders, cyc, scrim) was professionally cleaned, treated with fire retardant and tagged in accordance with fire code standards.

Other minor improvements include the installation of:

- shelving to store our drapery (curtains, legs and borders)
- shelving in the corridor between the stage and the dressing room
- video, data, communications, and paging to the storage shed

Technical procurements in the last 12 month include:

- Additional communication headsets and belt packs
- Four LED moving lights
- 9x Radio Microphones
- 16x Radio Microphone Headsets
- Radio Microphone belts and pouches

In June we sold some components of the *Mamma Mia!* set to The Performing Arts Collective freeing up much need set storage space.

The primary focus for the year ahead will be supporting Compliance Remediation Project activities, maintenance of our existing equipment and applying for grant funding to continue the replacement of our legacy incandescent lighting with more energy efficient fixtures.

# **PROPERTIES CUSTODIAN**

- 1). The year started with the annual clean-up, sorting and culling of the Props Room.
- 2). We found that many props are placed in the incorrect boxes even though they are well marked. This is an ongoing problem causing confusion when people come to hire props and we can't find them.(yet we know we have them)
- 3). We had several hires in 2022 especially schools. On the whole these are returned to us promptly but we are having problems with one of the schools who tend to hold the props longer than they should.
- 4). Can we have permission from the board to recharge after the agreed return time., if they have not been delivered. This caused problems with "Les Mis" as there were several props we had to resource from elsewhere because they were not returned on time.
- 5). If this is alright by the board, naturally we will inform the school when they hire the new rules. We feel that this is only fair when all our other hirer's return their goods in the prescribed time.
